











Report of the inception meeting of the National Sweetpotato Multi-Stakeholder Platform Held under the auspices of the AGRA Demand Creation and Impact Scaling Project for Orange fleshed Sweetpotato (DCIS) and the Ghana Sweetpotato Value Chain Association October 20, 2021

Participation: On-line (44); In person (23) at WASCAL Conference Room, CSIR Main Campus, Accra

The Sweetpotato Multi-Stakeholder Platform is intended to serve the interests of the Ghanaian sweetpotato industry as it pursues the goal of strengthening sweetpotato value chains to improve health and to generate wealth. The platform is envisaged to be industry-driven but draw on the support of diverse government and other agencies, including agricultural research and extension, education, health, media and lending institutions. The platform was established under the DCIS project but should outlive the project as a body to facilitate communication, articulate industry needs, and organize fora and initiatives to serve sweetpotato value chains.

This second meeting of the multi-stakeholder platform was held in a hybrid, virtual and inperson, format and included project consortium partners along with additional stakeholders from government, universities, and the private sector. Sixty-seven people participated in the meeting (photo gallery, program and attendance list are appended below). The links to most presentations made at the meeting are embedded in the program. Participants included various new private and public sector entrants who had not participated in the initial multi-stakeholder platform meeting. The meeting also attracted on-line participants from several countries, contributing to raising Ghana's profile as a leader in sweetpotato development. Link to zoom recording of the meeting.

The program ran from 9:30 a.m. to 3 p.m. and focused on progress and prospects on strengthening sweetpotato value chains in Ghana through private and public sector efforts. The program kicked off with welcoming and introductory remarks by Forster Boateng, AGRA Regional Director and Mrs. Nane Annan, Board Member of the Kofi Annan Foundation. These were followed by presentations on international experiences with sweetpotato value addition using puree by Mukani Moyo of the International Potato Center, and efforts at OFSP dissemination over the years in Uganda by HarvestPlus. Presentations from the Nigerian Sweetpotato Forum and the Economic Development Commission for Southern Africa highlighted additional interest and efforts from those regions.

The program then focused on progress and prospects in Ghana, including presentations by Fabian Lange about progress under the DCIS project; by Kwadwo Adofo of CSIR Crops Research Institute about sweetpotato varieties for diverse uses; by Seth Akoto, Directorate of Crop Services on programs of the Ministry of Food and Agriculture; and by Esi Amoaful on efforts by the Ghana Health Service to promote nutrition awareness and utilization of orange-fleshed sweetpotato. Emmanuel Darkey then presented on the Sweetpotato Value Chain Association, a private sector led organization that is expected to promote and strengthen sweetpotato value chains in Ghana beyond the life of the DCIS project. A panel

discussion which included representatives of the Ghana School Feeding Programme, the Women in Agriculture Development Program of the Ministry of Food and Agriculture, the Outgrower and Value Chain Fund, and the Office of the First Lady of Ghana provided information on the work of these agencies and ways that the DCIS project and sweetpotato producers and processors might interact with them. The formal program rounded off with a discussion of potential areas for future focus, with a consensus to work toward expanding use of sweetpotato in the Ghana school feeding, and to promote efforts to stimulate awareness of the potential for easy use of orange-fleshed sweetpotato in Ghanaian diets, thus enhancing demand and commercial opportunities for the crop.

The plenary program was followed by an awareness creation event consisting of an exposition/trade fair by enterprises engaged in sweetpotato production and processing. As an introduction to the event, which was held on an upstairs terrace in the WASCAL building, exhibitors had the opportunity to explain to the on-line audience what they would see at the fair. The zoom link was then moved to the upstairs terrace and each of the exhibits was interviewed. Exhibitors included

- Dorothy Kanney Company Ltd, a consortium partner on the DCIS project, which operates a newly established bakery at Kyebi. They displayed their bread made from puree.
- Maphlix Trust Ghana Ltd, a sweetpotato producer and processor displayed and sold fresh sweetpotato, gari made with orange-fleshed sweetpotato, and Ghanaian dishes made with sweetpotato, intended to give consumers an idea of what to prepare.
- Emmanuel Darkey & Associates displayed newly introduced orange- and purple-fleshed sweetpotato varieties with export and local processing potential, produced at their farm.
- Ohumpong Ghana Ltd and Ansedu Ltd. displayed numerous baked and other sweetpotato value added products (including noodles), some produced in association with Derbez Ghana, Ltd. They are a producer and processor of sweetpotato.
- KAZ Foods, a new entrant into the food processing space, displayed packaged fresh sweetpotato
- VOF Farms displayed fresh harvested roots and vines for planting material.
- Reputed Agriculture 4 Development Foundation displayed and distributed published materials on sweetpotato production and utilization.
- MoFA-WIAD gave a brief slide presentation during the introductory session, highlighting the multiple products that their agency and staff have developed. Noteworthy was a newly developed intensely orange-colored juice, along with a staggering array of traditional preparations and baked products incorporating OFSP.

Snacks and lunch at the event all featured OFSP and were generously contributed by consortium partners.

National press coverage of the meeting was well-organized by consortium partner, Fresh Logistics. Tv3, UTV and Joynews covered the event along with the Business Finder newspaper. Links to news reports are here: Media report 1, Media report 2, Media report 3

The hybrid meeting was well handled using AGRA-IT support as well as the services of a local videography company that managed the seamless integration of the remote and in-person video feed.

With MOFA-WIAD, the Ghana Health Service and the Ghana School Feeding Programme all engaged in strengthening nutrition education and bringing more healthy food into diets, the

fit with sweetpotato was very evident. However, for sweetpotato become common in school meals there is a need for it to be available at affordable prices. This is a challenge and opportunity for sweetpotato producers and processors. The Sweetpotato Value Chain Association is perceived as a key entity for carrying forward the development of the sweetpotato sector in Ghana. There is a need to strengthen governance and membership to build an effective and viable organization. The presentation by the Outgrower and Value Chain Fund provided information on affordable credit lines available to sweetpotato producers, which will certainly be of interest.

The consensus as the meeting closed was one of excitement at the possibilities and opportunities for pushing forward the development of sweetpotato value chains in Ghana, and determination to press on under the DCIS project to ensure maximum impact from the opportunity that this project affords to consortium partners and others in the sweetpotato sector. Additional multi-stakeholder platform and awareness creation events are planned under the AGRA-DCIS project, and we will do our best to maximize sustainable impact, including strengthening leadership of the Ghana Sweetpotato Value Chain Association.


